Based on the performance of the candidates in the 2nd stage Computer Based Test (CBT) conducted from 28-08-2019 to 01-09-2019 & on 19.09.2019 for the Junior Engineer(JEs),Depot Material Superintendent (DMS) and Chemical & Metallurgical Assistant (CMA) notified against Centralized Employment Notification (CEN 03/2018), 1808 candidates were shortlisted for the Document Verification (DV) & Medical Examination (ME) and called for DV & ME vide this Office Result Notice dated 6.11.2019 published on RRB/Chennai Official website.
