4. The candidates whose candidature is kept pending for receipt of medical fitness and pending clarification shall regularly visit the official website for further updates.
5. Document Verification (DV) will be held at Railway Recruitment Board Chennai, No.5, Dr. P.V. Cheriaan Crescent Road, Egmore, CHENNAI - 600 008. Candidates will be sent an Email/SMS to download their E-Call letter from official website of RRB with details of date and reporting time along with the instructions for Document Verification and Medical Examination.
6. Candidates may note that after completion of DV, they will be sent for Medical Examination at the nominated Railway Hospitals located in the jurisdiction of RRBs on the next day of DV. This will also involve travel from RRB to the city of Railway Hospital. Accordingly, candidates have to come prepared for DV & Medical Examination for more than 3 to 4 days. Candidates are advised to bring six (6) passport size colour photographs.
7. Regarding Medical Examination, candidates are advised that after completion of DV, medical examination will be carried out by Railway Hospital/Health Unit. Candidates have to pay the prescribed medical fee of Rs.24/- only. There are no other charges to be paid to the Hospitals/Health Unit for the medical examination. In rare cases, where the investigation like CT scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital/Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory/hospital.
8. Candidates are advised to upload Clear Scanned images of all the documents, colour scanned copy of their passport size photograph and signature in RRB Document verification Portal <https://oirms-ir.gov.in/rrbdv> duly following instructions mentioned therein. The shortlisted candidates for DV should produce original documents along with two sets of self-attested photocopies in A4 size as detailed in CEN & e-call letters.

9. Certificates produced during the DV should be in prescribed format and either in English or Hindi. Further, no additional time will be given to the candidates for not producing their original certificates on the date of DV. Candidates absent during the DV and/or medical examination will forfeit their candidature.
10. Candidature of all the shortlisted candidates for Document verification is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency/deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRB at any stage of the recruitment process. It may be noted that merely calling a candidate for Document Verification does not entitle him/her in any way to an appointment in the Railways.
11. Block date for verification of original documents for candidates absent on Regular DV date is as per Block date mentioned in the e-call letter.
12. Failure to report for document verification on scheduled date or block date will tantamount to rejection of candidature and no correspondence in this context will be entertained.
13. Candidates may note that all the recruitment related activities by Railways is purely on merit basis only and candidates are not required to make any payment to any authorities other than the prescribed Medical Examination fee of Rs.24/-
14. It may be noted that merely getting placed in the provisional panel does not entitle him/her in any way to an appointment in the Railways.
15. Candidature of all the candidates appearing in this panel is purely provisional and liable to be cancelled in case of any inconsistency / deficiency in the data furnished by them in their online application or at the time of DV or any malpractice on the part of candidates coming to the notice of RRB at any stage of the recruitment/ appointment process.
16. All original certificates will be checked once again by the Railway/Production Unit concerned, before appointment of the candidate.
17. While every care has been taken in preparing this provisional part panel and the list of candidates shortlisted for Document Verification RRB/Chennai reserves the right to rectify any inadvertent error or typographical mistake. RRB regrets inability to entertain any correspondence from unsuccessful candidates.
