Intimation about the Medical Fit / Unfitness of the Candidates

- Document verification (DV) for the various posts in Level-6,5,3 & 2 under CEN No. 01/2019 was conducted at this RRB on various dates from Sep-2022 to Sep-2023. Candidates whose DV was successful were sent for Medical examination at the nominated Railway Hospitals/ Health Units across Southern Railway Jurisdiction.
- Those candidates whose Medical fitness has been declared by Railway Medical Authority can view his/her medical standard on the link (Medical status as on 15.09.2023) provided for different Level in the website of RRB/Chennai.
- The following candidates who have been found unfit in the prescribed medical category for the post of Goods Guard/Jr. Accounts Assistant Cum Typist/Senior Clerk Cum Typist/Senior Commercial Cum Ticket Clerk/Commercial Cum Ticket Clerk/Accounts Clerk Cum Typist/Jr. Clerk Cum Typist/Trains Clerk have the option to prefer an appeal to the Principal Chief Medical Director (PCMD), Southern Railway, Chennai.

- Candidate who desires to prefer appeal against the decision of the Railway Medical Authority may submit the same, with relevant documents mentioned below to the Chairman, Railway Recruitment Board, Chennai before 18.00 hours of **25.10.2023**. They should submit the appeal by Registered post /Speed Post only.
- Those candidates who have not attended medical exam / absconded or absented willfully for medical examination before the nominated medical committee for review are not eligible to apply for appeal.
- Earlier, the medical status of the candidates called for Level-5,3&2 was published through website of RRB/CHENNAI as on 26-05-2023, based on which Notice dated 15-06-2023 for preferring Medical appeal was published. Those who did not prefer Medical Appeal against the notification dated 15-06-2023 or whose appeal has been rejected are not eligible to apply for Medical Appeal in this notification.

Procedure for Appeal

The appeal will be entertained only if:-

- The candidate produces a certificate in the attached prescribed format (**Proforma A**) from a Government/Private Doctor of the specialty/specialties in which the candidate has been found unfit.
- Such certificate should contain a note that the Government/Private specialist is fully aware of the physical and visual standards set by the Railways for the particular medical category, and that he is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate medical board.
- The certificate should bear the photograph and mark of identification of the candidates duly attested by such a Government/private medical certificate issuing authority duly mentioning its MCI/State registration number.
- Candidate will be required to pay Rs.1000/- (Rupees One thousand only) through Demand Draft payable in favour of FA&CAO / Southern Railway, Chennai.
- Where PCMD is of the opinion that there should be re-examination of the case of appeal, he may nominate a medical board to re-examine the candidate. The decision of PCMD, Southern Railway on the appeal preferred by the candidates will be communicated to them through RRB/Chennai.
- In case, the decision changes from unfit to fit, the amount of Rs. 1000/- submitted through DD will be returned to the candidate. In all other cases, the DD amount will be forfeited and the candidates will not have any claim on the same.
- After this appeal no further chance will be given for medical examination.

Note: Appeal against the medical unfit should be sent in his / her own handwriting with signature. The format of specimen appeal is given as Annexure B. The appeal will be entertained with the appeal letter, Proforma A & DD for Rs. 1000/-.
